Northern Leaf is a medical cannabis cultivator based in Jersey. In December 2020, it became the first company in 22 years to be granted a commercial high THC medical cannabis license by the UK Home Office. With a secure, operational facility already built, Northern Leaf will grow commercial quantities of medical cannabis for the rapidly growing European market, including the key markets of the UK, Germany, and Israel.
