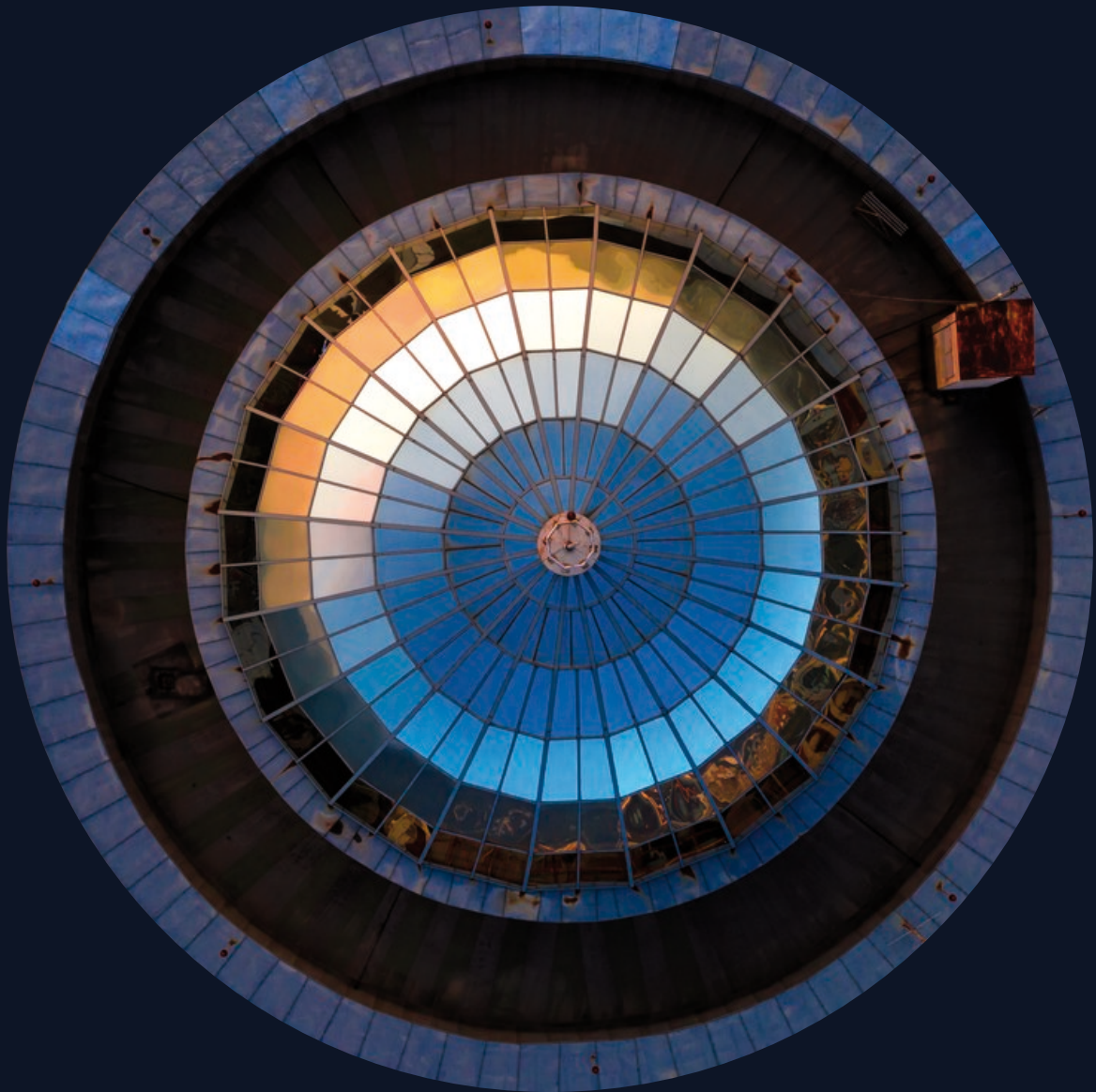

We advise both lenders and borrowers in respect of all aspects of aircraft financing and have extensive experience in structuring and advising on the security

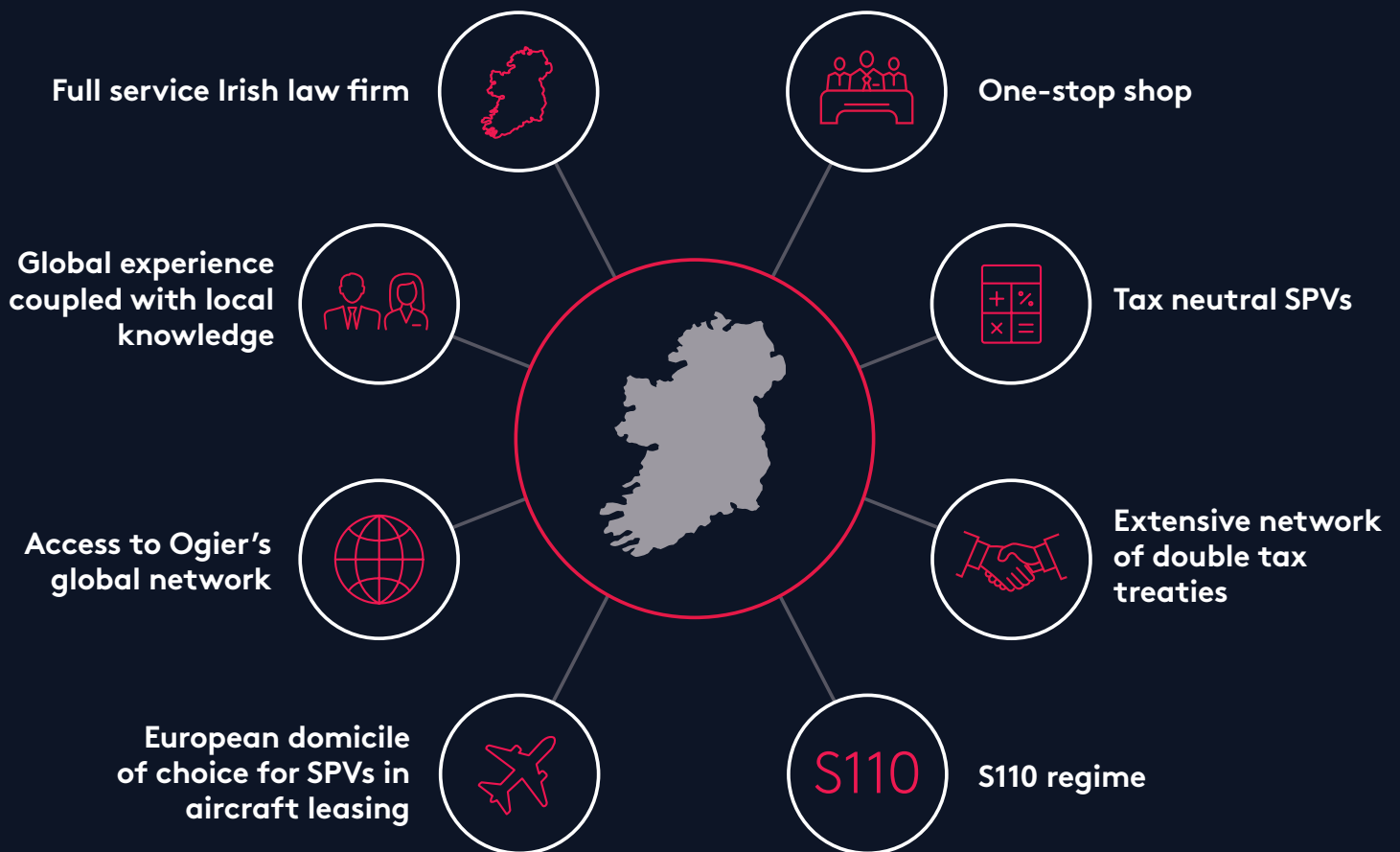
granted in relation to such financings. Our team advises in respect of all types of debt products including those utilising structured finance solutions.

### Acquisitions, sale, transfer and finance

### Dispute resolution

Our team bring applications for interim relief to "hold the ring" pending the determination of any proceedings (whether commenced locally or in a foreign jurisdiction) concerning aviation assets, including seeking the appointment of receivers or seeking a freezing injunction.

## Tax services in Ireland

### **Why Ireland for aircraft leasing and finance?**

Ireland offers a competitive corporate tax rate of 12.5%, making it an attractive location for financial services companies. The country also provides wide withholding tax (WHT) exemptions, enhancing its appeal with a robust tax treaty network and exemptions on dividends, interest and royalties. This favourable tax regime has established Ireland as a reliable domicile for aircraft leasing and finance.

For asset backed securitisation, Ireland's tax environment is particularly beneficial for entities known as Section 110 companies.

Capital allowances are available for acquiring a broad range of intangible and tangible assets, such as aircraft. Certain goods and services, notably most financial services, are exempt from VAT, contributing to Ireland's advantageous business climate.
