## 5 things to know about Ogier Global Hong Kong AEOI (FATCA & CRS) Services



Where required, register the Fund and any associated Entities with the US Internal Revenue Service (IRS) to obtain a Global Intermediary Identification Number (GIIN) and with the relevant tax authorities prior to the applicable deadlines



Subject to receipt of the relevant financial account information, assemble and format the required FATCA and CRS reports, subject to the applicable jurisdictional requirements



Review documentation for indicia and any inconsistencies between the self-certification forms



Deliver to the Fund and its directors annual confirmations of the completion of the reporting obligations within 14 days after filing



Monitor all documentation for expiration in accordance with the Tax Transparency rules and regulations
