DAOs and DeFi

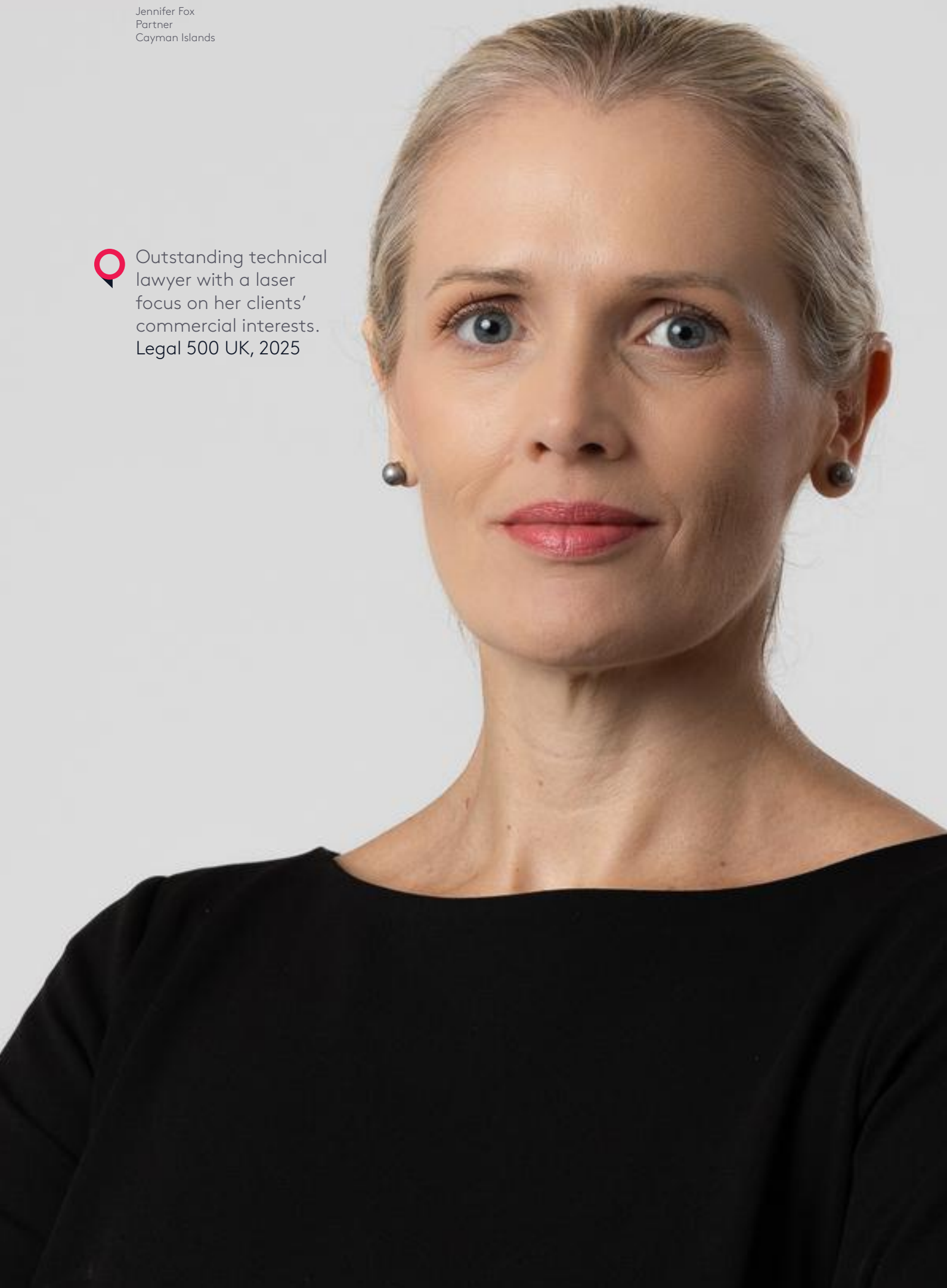
